APPLICATION CHECKLIST

A REQUEST FOR A DETERMINATION LETTER FOR AN EMPLOYER'S ADOPTION OF AN APPROVED VOLUME SUBMITTER PLAN MUST INCLUDE THE FOLLOWING:

1. Completed Form 5307
2. Schedule Q (Nondiscrimination Requirements), (filing is optional; see Announcement 2001-77)
3. Completed Form 8717
4. Written authorization allowing the volume submitter practitioner to act as a representative of the employer with respect to the request for a determination letter
5. Copy of volume submitter advisory letter
6. Copy of plan and trust document
7. **Written representation which states the plan and trust are word-for-word identical to the approved specimen plan or an explanation how the plan and trust instrument differ from the approved specimen plan, describing the location, nature and effect of each deviation from the language of the approved specimen plan**
8. Copy of the plan's latest favorable determination letter, if applicable
9. Any other items required per Rev. Proc. 2000-6 or its current update
